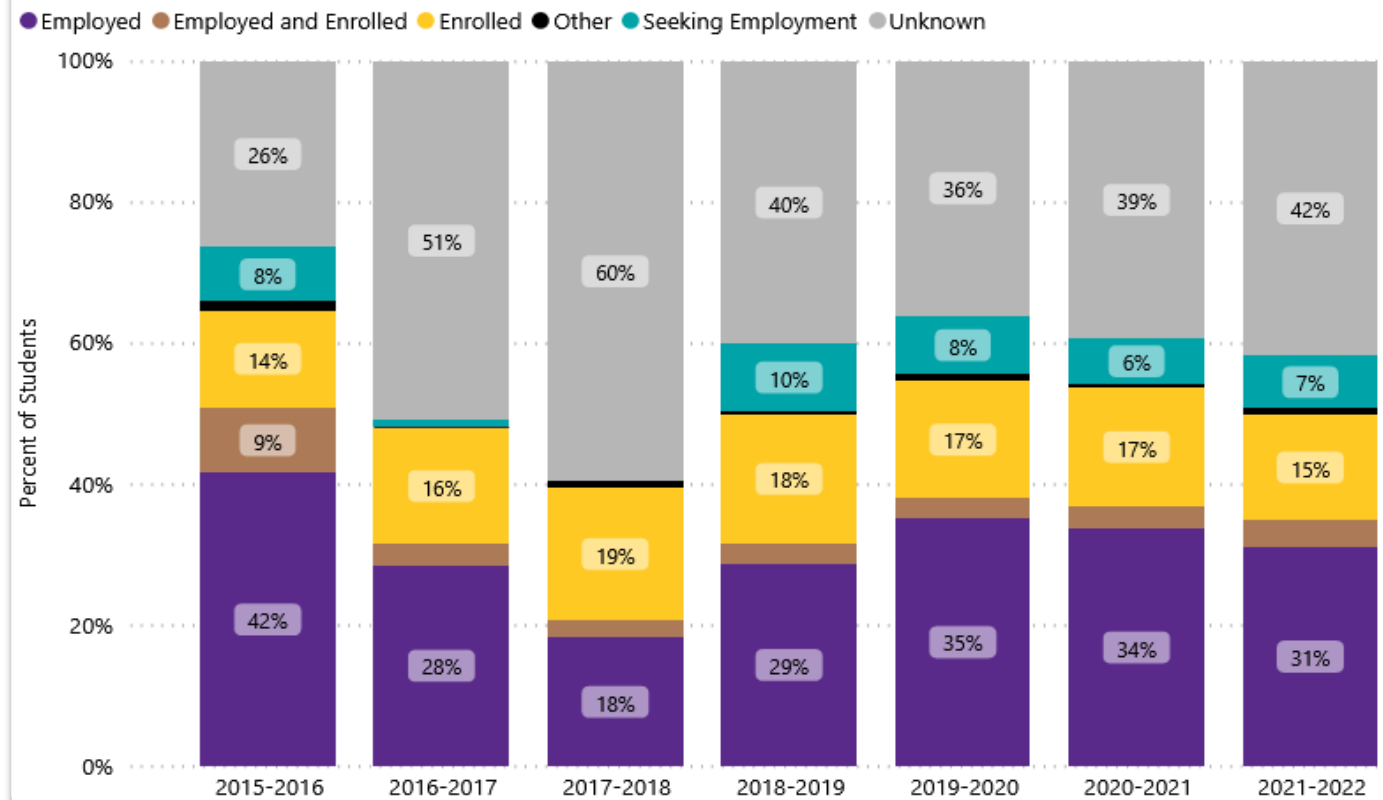
Survey Update

Student Surveys

- ▶ Graduating Senior Survey (GSS) & Graduate Student Exit Survey (GSES)
 - ▶ Summer graduates surveyed July 18 – Aug 17
 - ▶ Response rates
 - ▶ GSS: 18%
 - ▶ GSES: 32%
 - ▶ 2022-2023 results visualized in [IPAR Business Intelligence App](#)
 - ▶ College, department, and program level reports available upon request
 - ▶ Fall 2023 graduates will be surveyed starting in November

- ▶ Survey of Student Opinion of Instruction (SSOI)
 - ▶ First Summer Session: June 13 – 19
 - ▶ 11-week & Second Summer Sessions: July 21 – 27
 - ▶ Reports released two weeks after survey end date

- ▶ Response rate: 49%

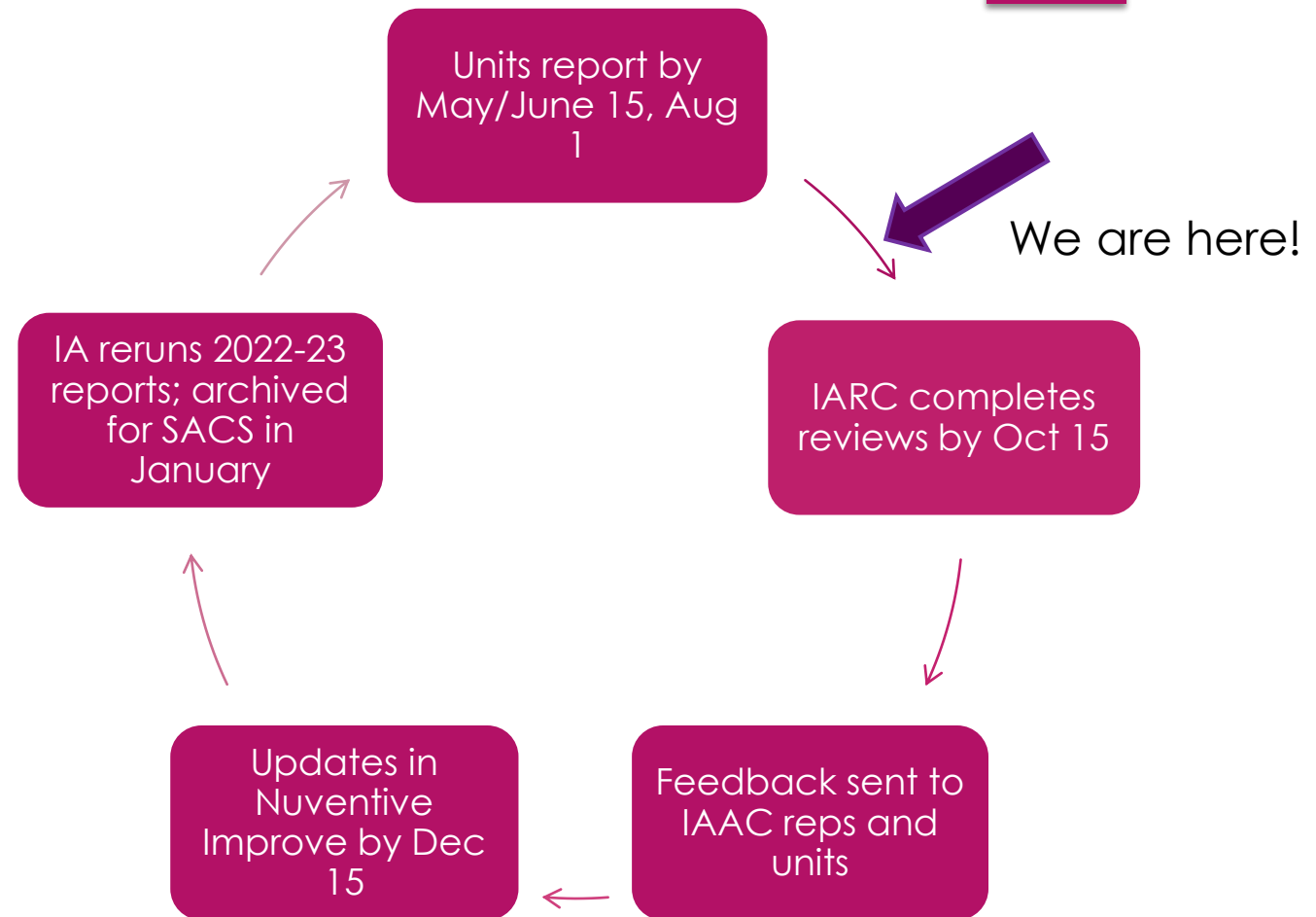
▶ Administrator Survey

- ▶ Received link via email from Qualtrics
- ▶ Reports released on May 11
- ▶ Response rate: 23%

- ▶ 35 reviewers for 68 educational programs (9 new reviewers)
- ▶ 13 reviewers for 26 support units (1 new reviewer)

Improvements to the GE Assessment Process

- **Increase Communications**
 - Regular updates at the beginning of each semester
 - Transition meetings for new person
- **Streamlined Collaboration**
 - Utilization of Microsoft Teams for file sharing and collaboration.
 - Private team channels for each competency area.
 - Individual folders for each department within each channel.
- **Efficient Syllabi Review**
 - Team channels established for each competency area.
 - Syllabi organization by reviewers.
 - Review link and instructional video link in one place.

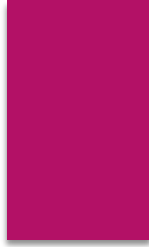
Improvements to the Assessment Process

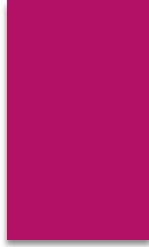

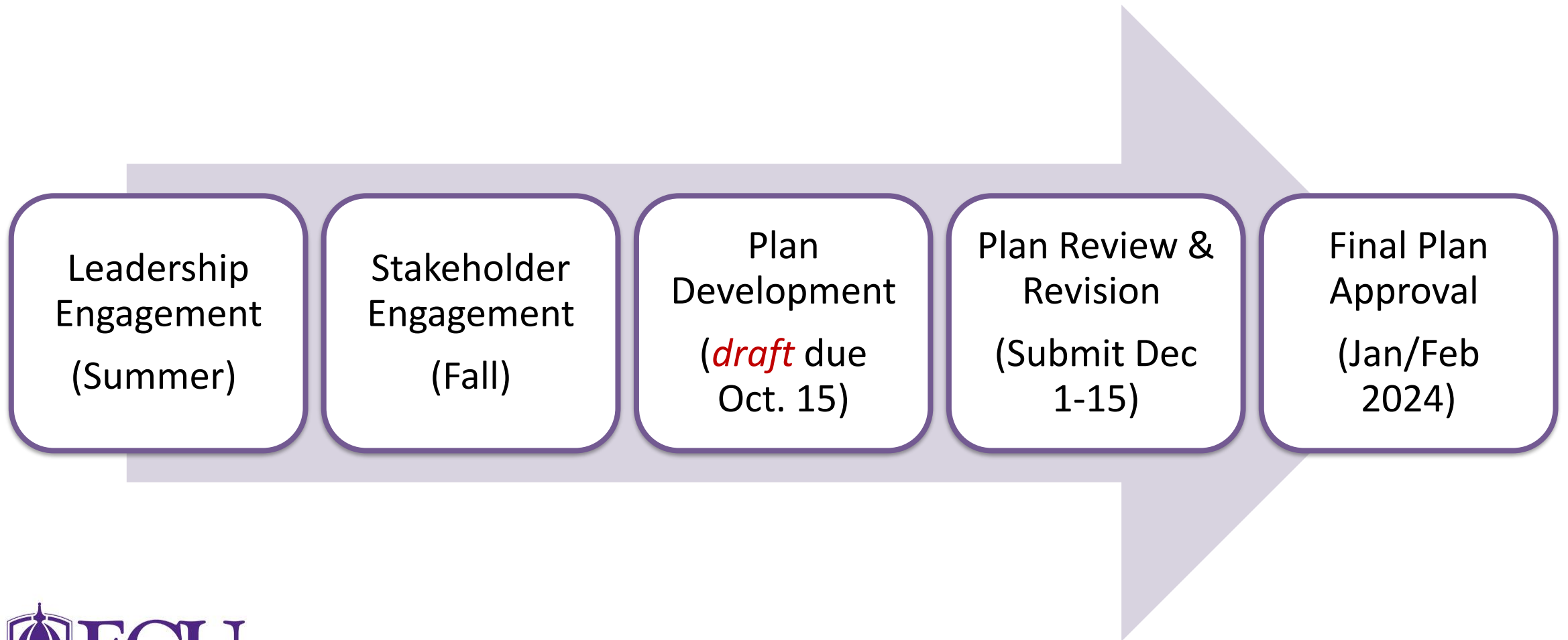
