Assessment Reporting Update

• 2023-24 assessment reports are due May 15 for 9-month faculty and June 15 for 12month faculty. Institutional Assessment (IA) will be sending out reporting reminders this week.

Summary of Institutional Assessment Review Committee Process (IARC)

- 68 educational programs and 26 support units were reviewed by the IARC in Fall 2023.
- Results from the IARC:

- Units in the "20-39% No Responses" received targeted emails. Units in the 40% or more No Responses" were contacted to schedule a consultation with IA to review the feedback.
- IA has had consultations with 12 of the units (75%) in the consultation group. IA has also met with 10 additional units in the other "no" groups.
- The percentage of units who either did not need to make updates to their report (all yes) or made updates to their report was 86%, which was the same as last year. The percentage of units who did not make updates based on the feedback was 13%, which was the same as last year as well.
- The IARC structure has been in place for 4 years. The first 1/3 of educational programs that was reviewed in Fall 2020 were reviewed again in Fall 2023. IA is using the IARC results over time to identify units that consistently 1) don't do well on the IARC reviews and/or 2) don't make updates to their reports based on the feedback.

General Education Assessment

- GE Fine Arts competency assessment data collected from the sampled courses offered in all four schools of CFAC in Fall 2022 & Spring 2023.
- A total of 1619 student artifacts were collected for the assessment.
- Students performed well on all three outcomes: 89%, 96%, and 90% students met or exceeded expected outcomes for SLO 1, SLO 2, and SLO 3 respectively.
- Based on the course delivery mode, students taught in online mode performed better than taught in face-to-face mode in SLO 1 whereas students taught in face-to-face mode performed better than the students taught in online mode in SLO 2 and SLO 3.
